
BT October Meeting Monday, October 4th – 6:30 PM



President's Corner

(Or the ravings of a BT madman)

September turned out to be a great LBC driving month. We finally got some decent summer weather and hardly any rain. Two big events occurred during the month, the "6-Pack Trials" and the SCCA Runoffs at Mid-Ohio. In case you don't know about "6-Pack", it is the national club for TR250s and TR6s. The SCCA Runoffs are the national championship races to determine the best cars and drivers in the numerous Sports Car Club of America race car classifications.

The 6-Pack "Trials" in Door County, Wisconsin was better than I could have imagined. We drove a total of 1,300 miles and never had the top up during the whole trip. The weather was just about perfect and the New Castle Brown Ale was always cold. It doesn't get much better than that!

"Trials" didn't officially start until Thursday, September 16th, but we left for Ludington, Michigan on Tuesday of that week to enable us to catch the carferry to Wisconsin on Wednesday morning. Our traveling companions (and future condo-mates) were John and Becky Hartley. After stopping in Bowling Green, Ohio, for a late lunch, we made it to Ludington by early evening. We got checked into our motel, then we piled into the Hartley's Chevy to find a decent dinner spot. We settled on a local pizza joint and their pizza was great. We needed to be at the dock to load our cars onto the carferry, S. S. Badger at 8:00 AM, so we made it an early night. After a quick breakfast, we drove to the dock and we had to be screened by some security person and her friendly-looking dog prior to boarding the ferry. Once on board, we met up with several of the 6-Pack members from Indiana. It was a very windy day and our Lake Michigan crossing was rather rough. Some of passengers got sick, including an Indiana 6-Pack member who I will divulge later. (For those who might be interested, the Badger was built in 1953 as a railroad car ferry. She is a steel ship 410' long, 60' wide and she draws 20' of water. She is powered by 2 steam engines that are 7,000 HP with coal-fired boilers. After railroad car hauling duties, she was not used for a number of years. Later, she was refurbished and began carferry duties in 1997.) After nearly 4 hours, we landed in the port of

Manitowoc at noon. (We gained an hour somewhere in the middle of the Lake.) After lunch, we had another 75 miles to drive north to Door County. We took the recommended scenic route and drove through some unspoiled county. We finally arrived at our destination in Egg Harbor and we checked into the host location, which was a condo community called the Lakeside Resort. The Resort overlooks a portion of Green Bay and the surrounding views are breath-taking. The Hartleys, Charma and I shared a loft condo, which worked out very well. By sharing, we were able to save a little money and we were able to enjoy each others company. Several 6-Pack members (including the Merciers and VanOrders) had already arrived, so we were able to renew old friendships and drink a few cold ones in Jeff and Karen Rust's "Captain's Room" which doubled as the hospitality suite. On Thursday morning, several of us met for breakfast at a place called the "Village Café". Everybody enjoyed a delicious meal, but nothing on the menu came from a Weight Watchers cookbook. I had a wonderful veggie quiche and a blueberry pancake. Afterwards, we did some serious shopping in the many shops of Door County. We started our day at a British shop, where we found several things that we just had to have. I scored a couple of English metal road signs and flags; Charma found some flavored curd, a compressed heather ring and a couple of cans of Heinz Spotted Dick. (Don't they administer penicillin for that?) Later, we found a classy Irish shop with Waterford crystal and fine china. Naturally, we skipped the good stuff. John and I went straight for the tacky green plaid tams with orange hair attached, which we wore over the course of the weekend. While wearing our tams, we even got our picture taken next to an ice-cream shop sign which read, "Not Licked Yet". (I'm not making that up, either. There may be a photo attached to prove it.)



For lunch, we stopped at a Swedish restaurant, which had a grass roof and real goats on top to keep it trimmed.

On Thursday evening, the 6-Pack festivities began with a cookout sponsored by our "Trials" hosts. They grilled hamburgers and hot dogs and provided potato salad and chips. Of course, the ever-present coolers full of New Castle and lesser ales and beers were there as well.


Some people stayed outside after dark, but most of us moved indoors once the temperature dropped into the 50's.

On Friday, we slept in a bit, and then, we ate a cereal breakfast in our condo. Afterwards, we did a little more shopping, and then, Charma and I took a leisurely drive in our TR6 cruising to the north end of the island. In the late afternoon, we all lined up for a tour which ended on the east side of the island at a restaurant called the "Sandpiper". There, we were treated to a culinary delight, a Door County fish boil. It starts with, what else, a huge pot of water over a hardwood fire. When the water comes to a full boil, potatoes, onions and pieces of white fish are thrown into the pot. After about an hour, the master boiler throws a large coffee can full of kerosene into the fire. Naturally, it flames up like hell. I am told that the reason for this is to burn off the fish oil at the top of the water. (Personally, I think that it is merely for effect.) Anyway, they serve it all up with coleslaw and it is delicious. At the end of the evening, I closely followed Murry back to Egg Harbor because I had a burnt out headlight.

On Saturday, I started my day by washing my dirty and bug splattered car. I wasn't concerned about prepping it for the concours, but it was just too filthy to put it with the rest of the "Participant's Choice" cars. As usual, there were some fantastic TR250 and TR6 show cars on the tarmac. Some of the cars are in far better condition than were ever cranked out in the Coventry factory.

After the car show, there was a "fun" rally around Door County. Course instructions were given to all participants with blanks to be filled in with answers to numerous questions. For some strange reason, the rally masters sent everyone away simultaneously, which made for some initial bunching up. Some of the questions were easily answered and some were open for interpretation, which presented a challenge for marriages and/or relationships. Charma and I turned back once because we had missed finding an answer. Unfortunately, it didn't help because we missed it a second time through. Apparently, participants had to know of a TV commercial for "Travelocity" (to be able to know what to look for. Having never seen the commercial, it made absolutely no sense to us. Anyway, we persevered and answered most of the questions.

After the rally, we had enough time for a quick sprucing up, and then, it was on to the awards banquet. The food wasn't the best that we have ever had at a banquet. As a matter of fact, I think that the chicken must have died of old age. But other than the chicken and soggy corn, the meal was fairly decent. After the meal, 6-Pack Chairman, the "Trials" organizers were recognized and door prize tickets were pulled. Everybody got a prize, which is a really nice touch and was well appreciated. 6-Pack Chairman, Matt Mullins attempted to call out numbers, but he had to be relieved by Karen Rust, because he was nursing a bad cold and he had lost his voice. After all the door prizes were distributed, the various awards were presented. Then, the awards were given for the fun rally.

Then, we motored down to Manitowoc to get ready for our boat trip back across Lake Michigan. Once we reached Manitowoc, we had a little time to kill before loading, so we went through a very nice maritime museum and took a tour on a submarine. Pretty cool. While waiting at the dock, an elderly gentleman from Philly, Pedro, and his wife, Connie, rode past our cars in their

TR6 being pushed by one of the boat staff. I ran up to their car and asked Pedro what the problem might be. Under his breath, Pedro muttered that he had run out of gas. Just make sure your brakes are in good working order.

Last weekend, we attended the SCCA Runoffs at Mid-Ohio race course in Lexington, Ohio. On Saturday, the Merciers, Charma and I drove up together and we took our TR6s. It was brisk, but being die-hards, we kept our ragtops down. We arrived during the first race of the day and we drove into a packed infield. We took our fold-up chairs to the hill overlooking the end of the straight away and the "esses" (which are turns 9, 10 and 11). We ran into Roy Gay and we were later joined by Bruce and Ryan

Miles. We saw some dynamite races with lots of pushing and shoving going on. Since these are the runoffs for "all the marbles", these guys aren't messing around. During one race, three big American V8 cars tried going into the esses alongside each other, but only two came out the other side.
